pursuant to article 13 of Regulation (EU) 2016/679

In accordance with Article 13 of the General Data Protection Regulation - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (herein after "GDPR"), we would like to explain how we collect, process, disclose and protect the personal data that you provide by completing the contact form on this site (<https://www.brinver.it/contatti/?lang=en>).

1. DATA CONTROLLER

The Data Controller of Personal Data is **BRINVER S.R.L.** with registered office in Via Treviglio, 40 - 24053 - Brignano Gera D'Adda (BG) – ITALY.

2. PURPOSES AND LAWFULNESS OF PROCESSING

By clicking on the "SEND MESSAGE" button, your data are processed to let you to send a request of information and to be contacted via the dedicated form.

The legal ground is the express **consent** of the data subject.

3. CATEGORIES OF PERSONAL DATA

The categories of personal data subject to processing include **personal details and contact data** (e.g.: name, e-mail).

These data are required to handle and follow up on the data subject's request.

4. MANDATORY OR OPTIONAL PROVISION OF PERSONAL DATA

The provision of personal data is generally **optional**. However, failure by the data subject to provide the personal data needed as stated in the foregoing shall result in the impossibility to handle the request.

5. DATA RETENTION TIME

The Personal Data being processed for the abovementioned purposes will be retained in compliance with the principles of proportionality and necessity and, in any case, until the purposes of the processing have been achieved.

So, the data collected will be kept for the period necessary to **respond to your contact request**.

6. PLACE OF DATA PROCESSING

The treatments connected to the web services of this Site take place at the Supplier's headquarters and are only handled by subjects authorized to carry out the activities necessary for the execution of the stipulated contract. No data deriving from the web service is communicated or disseminated except in order to perform the service or provision requested and exclusively for this purpose.

7. SECURITY OF PERSONAL DATA

Personal data, possibly collected on the Site, is protected from unauthorized access, use or disclosure. Only personnel specifically appointed by the Supplier and equipped with their own authentication credentials can access these data. All the security procedures necessary to protect the data from violations by unauthorized personnel, both locally and on the network, have been applied. All personal data that is provided to us is, in fact, stored in a secure and controlled environment. To this end, physical, electronic and organizational processes have been set up to safeguard and protect the information collected, including the use of firewalls, antivirus and connection protection.

8. TRANSFER OF PERSONAL DATA

Your Personal Data will be processed within the European Union and stored on servers located within the European Union. The same data may be processed in countries outside the European Union, provided that an adequate level of protection is guaranteed, recognized by a specific adequacy decision of the European Commission.

Any transfers of Personal Data to non-EU countries, in the absence of a European Commission adequacy decision, will only be possible if Data Controllers and Data Processors involved provide adequate guarantees of contractual nature, including Binding Corporate Rules and Standard Contractual Clauses.

9. DATA SUBJECTS' RIGHTS

- e) oppose processing;
- f) receive your data in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance, where technically feasible.
